### What is the Partnership Board for?



The Partnership Board has been set up to make sure that people know about the Pembrokeshire Learning Disability Strategy and that recommendation are completed.

In this document the Pembrokeshire Learning Disability Strategy will be called the Strategy.

# The Partnership Board will work together to make things better for people with a learning disability.



- It will support partners to deliver the strategy for people with learning disabilities in Pembrokeshire
- It will make sure that the Strategy makes a positive difference to people's lives
- It will support services to deliver national policies
- It will make sure that people with a learning disability have the same opportunities as everyone else.





- It will make sure that everyone has a voice and the chance to ask questions about decisions and services that affect them
- It will represent people with learning disabilities and their families. Members of the board will bring and share their questions and ideas



# The Partnership Board will influence decisions:


- It will give advice to, and share information with, other key partnerships in Pembrokeshire
- It will influence and shape the decisions of other key partnership groups
- It will make sure other people, services and agencies who write policies, think about how they affect people with learning disabilities and their families
- It will help other agencies to consult and communicate with the Partnership Board
- It will hold services to account, support and challenge them



### The Partnership Board will talk about the Big Things that affect lots of people:

- It will find out what things affect people in Pembrokeshire
- It will agree the work plan for the Board

### How does the Partnership Board make sure this happens?





- It will make links with and send regular update reports to other key Pembrokeshire partnerships
- It will set up subgroups to work on the key aims of the Strategy and other key pieces of work as they come to the Board's attention

#### How will the Board make decisions?



- Information at meetings will be easily understood by all Members
- It will use Meeting Rules which have been agreed by people with Learning Disabilities
- If there is a decision to do something, everyone will be told when it will be done by and how this will be checked
- The Board will be clear on who will do the work that needs to be done

### What will the Board check up on?



- How well is the Partnership Board achieving its goals?
- Is the quality of people's lives improving?
- How well is Pembrokeshire achieving the key aims of the Pembrokeshire Learning Disabilities Strategy?
- How well is Pembrokeshire achieving the aims of other national policies for people with learning disabilities?
- Are people with learning disabilities and their families involved in decisions that affect them?
- Are people doing the jobs they say they will do?

### How will we check how we are doing?



- We will talk to people to find out how well they think we are is doing
- We will agree actions and checking that they have been done
- We will ask for feedback from the Partnership Board sub-groups
- We will write an annual report or hold an annual event to tell people about what we have done.


### How will we communicate with people?

### How will membership be decided and how will members vote?



- Membership will be nominated by members of the of the Partnership Board.
- Each named Board member is entitled to 1 vote.
- Advocates, support workers and secretariat will not be seen as voting board members
- The Chair, Co-Chair, Vice Chair and Co-Vice Chair will carry out their duties for 12 months. After this time, members will take a vote on who will take on these duties next.



### **Subgroups**

- Representatives from other services (eg. housing, transport, employment, education, leisure etc) should be drawn on when necessary and included in the sub-groups set up by the Board
- The Chairs of each sub-group should take responsibility for inviting the relevant people to attend Partnership Board meetings when discussions are taking place around their areas of responsibility

### How many people are needed for the meeting to take place?

- There must be 6 members of the board at the meeting for it to take place.
- For decisions to be made, the Chair or Vice Chair, a person with learning disabilities and a

member who is senior enough to make decisions on strategies and plans must be at the meeting.

### Who will Support the Board?

 Pembrokeshire County Council will provide support for the Partnership Board

### How often will the Board hold meetings?




- A Board meeting will be held every 2 months
- All members of the Partnership Board are expected to attend each meeting
- If any members cannot attend, they should send apologies before the meeting
- If representatives cannot attend, they may send a deputy

#### Reimbursement


- Citizens, parent/carers and support workers who are involved in any Partnership Board activity lasting over 2 hours will be provided with beverages (tea/coffee/water etc).
- People participating in activities lasting over 4 hours will have light refreshments provided for them, depending on the time of the activity.
- Citizens, parent/carers and/or support workers are entitled to be reimbursed for any reasonable expenses, as agreed in the expense Reimbursement Protocol. This protocol covers reimbursement for travel costs and the cost of replacement care.
- All other expenses incurred in relation to involvement with the work of the Partnership

Board will be considered on an individual basis.



### **Agendas and minutes**






- Papers will be available in Welsh if requested by any board member.
